L. Reports of Councilmen

Mayor Rigsby noted the IVDA roster was available.

Mayor Rigsby mentioned that San Bernardino Mayor Carey Davis was looking to convene interested parties from surrounding communities to discuss strategy and to coordinate the overnight homeless census this coming year and extended that invitation to staff and interested Council members.

Mayor Rigsby noted the proliferation of shopping carts from surrounding areas, he has picked up and returned to their place of origin. Assistant City Manager indicated that a call to our Public Works Department would get them picked up as well.

M. Reports Of Officers

Assistant City Manager updated the City Council regarding the homeless population in the City indicating that City Code Enforcement was working with the Public Works Department and the Sheriff's Department on clean up the homeless encampments in various locations around the City. Code Enforcement and the Sheriff make sure they are ok, in the city on legitimate business and offer services that are available; Public Works work on clearing out any encampments. He noted we were making some progress on what was a State-wide issue.

Fire Chief Bender clarified the remedies available regarding the cost of fire medical program that had been brought forward at a previous meeting. There was no mechanism in place at this time to lessen the actual cost of the Fire Medical Program.

Fire Chief Bender noted the mutual aid being provided to Northern California's Carr and Mendocino Complex fires, that there had been a recent crew swap and those currently deployed should return in approximately 14 days.

Fire Chief Bender also noted a fire earlier in the day in the field next to the Arco station at Barton Road and California Street was a couch in a homeless encampment.
